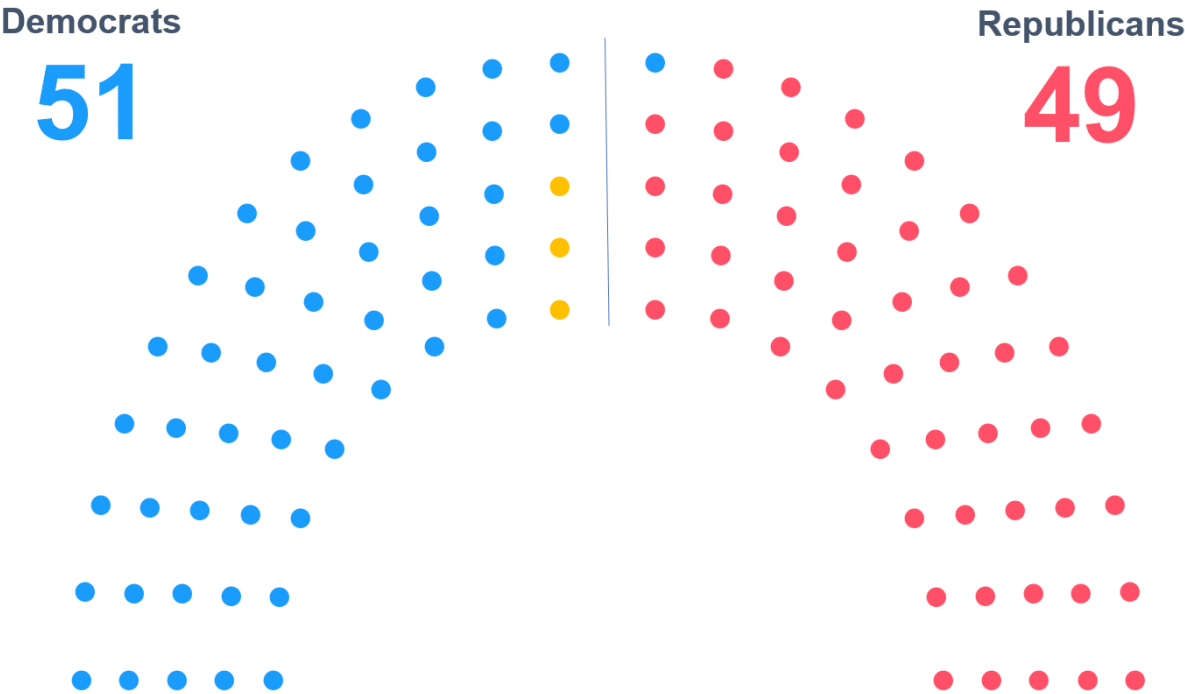

Senate Balance of Power

Following the 2022 general election, Senator Kyrsten Sinema of Arizona left the Democratic party to become an independent but has retained her committee assignments alongside Democrats in the chamber giving Democrats a 51-49 seat working majority. Following the death of Sen. Dianne Feinstein, California Governor Gavin Newsome appointed Laphonza Butler to fill the vacancy, maintaining the 51-49 majority for Democrats in the chamber.

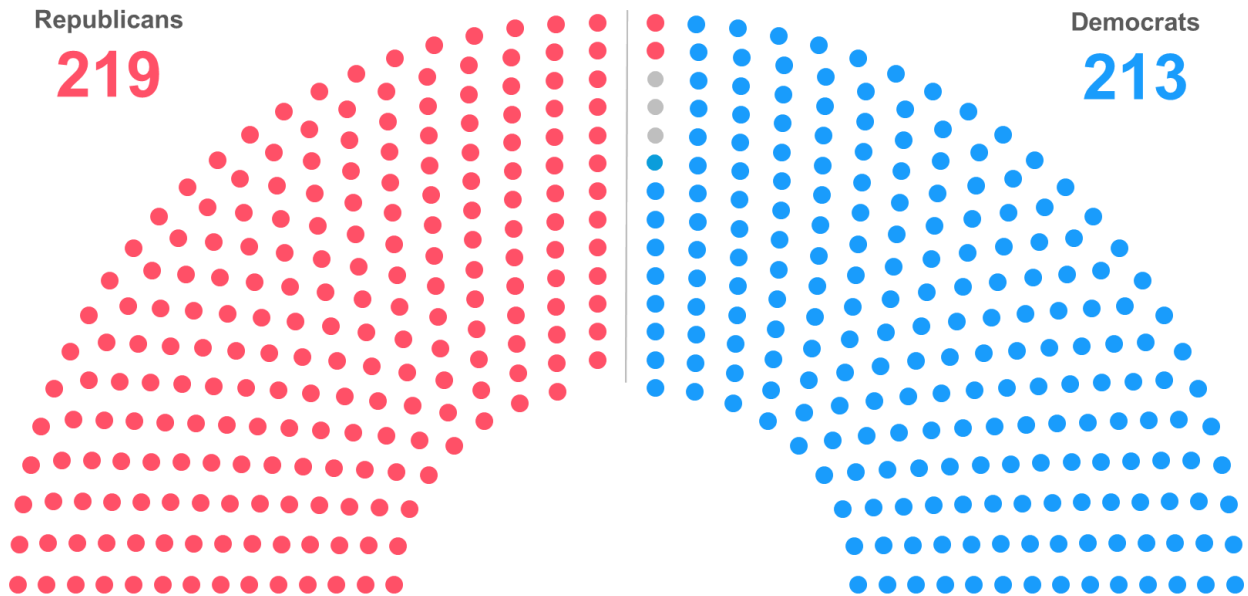

House Leadership

In October 2023, Rep. Mike Johnson was elected to the office of Speaker of the House after former Speaker Kevin McCarthy was ousted from the role by his own party. For House Democrats now moving into the minority, the former slate of leaders have vacated their positions to usher in a new generation, led by Minority Leader Hakeem Jeffries of New York.
